### RECOMMENDATIONS FROM EXECUTIVE SESSION

## A. Student Disciplinary Hearing

A motion was made by Mrs. Balsley and seconded by Mrs. Zwart to expel Student 2010A for one calendar year until March 12, 2011 for the following offense: "Using, possessing, distributing, purchasing, or selling: Any illegal drug, controlled substances, or cannabis (including marijuana and hashish)." The expulsion will be stayed if Student 2010A:

- 1. Obtains a drug/alcohol assessment at Rosecrance at the parents' expense (assessment results are to be sent to the Superintendent's office);
- 2. Completes such treatment program as recommended by Rosecrance; and,

- 3. Obtains monthly drug tests from April through June 2010 and resuming August 2010 through March 2011 at the parents' expense (submit test results to the Superintendent's office).
- 4. There are no other incidents of gross misconduct during the expulsion period.

If student 2010A does not provide a drug/alcohol assessment or does not complete the recommended treatment program or does not submit a negative drug test monthly as required or is involved in an incident of gross misconduct, this expulsion will be reinstated immediately.

The Board recommended that Student 2010A perform 40 hours of community service by the end of June 2010 and that the student submit a log of such service to the Superintendent's office when completed.

The motion was carried by unanimous roll call.
