EXECUTIVE SESSION

A motion was made at 6:00 p.m. by Mrs. Balsley and seconded by Mrs. Zwart to recess to Executive Session to discuss student disciplinary matters, or other matters provided for pursuant to §2(c) of the Open Meetings Act. The motion was carried by unanimous roll call.

RECOMMENDATIONS FROM EXECUTIVE SESSION

A. Student Disciplinary Hearing

A motion was made by Mr. Crull and seconded by Mrs. Zwart to expel Student 2011-02 for 2 calendar years for the following offense: "Using, possessing, distributing, purchasing, or selling: Any illegal drug, controlled substances, or cannabis (including marijuana and hashish)." The expulsion will be stayed effective April 4, 2011 if Student 2011-02:

1. Successfully completes the recommended drug treatment program; and,
2. Undergoes monthly drug tests for the two calendar years at the parents' expense, the results of which must be submitted to the North Boone Middle School administrator.

Student 2011-02 is also prohibited from attending any extracurricular activities for the balance of the two-year expulsion. If student 2011-02 does not successfully complete the

recommended drug treatment program, does not submit a negative drug test monthly as required or attends any extracurricular activity not approved by the building administrator, this expulsion will be reinstated immediately.
