Temporary drivers will be used at the beginning of the school year as necessary. When asked, the Board did not voice disagreement with Dr. Baule's suggestion that if a substitute works more than 30

days, that individual should be hired. In that way the employee would obtain seniority based upon their actual start date.

The Board also voiced no opposition to continuing to allow bus drivers who live within 1½ miles of their child's school to continue to bus their children as long as space allows.
