**A. PMA Investment**

At the Regular Board Meeting on September 26, 2017, Mrs. Saunders had shared that one of our PMA investments may be at risk due to an investment of a bond with a B+ rating. Based on her conversations with PMA, it was estimated we could lose \$3.7K trying to call the bond for the \$635K investment. Mrs. Saunders said PMA would watch the situation and she was under the impression that they felt it was not a large enough risk to call the bond at this time. Dr. Greenlee had spoken to Poplar Grove State Bank regarding this bond and it was their opinion that the risk is high and reward is small if we keep this investment. A motion was made by Mrs. Maxey and seconded by Mr. Moon to sell the Alton School District bond.
