B. Requested Tutoring Update

Kari Neri presented a tutoring update to show how the after-school tutoring and Paper is funded and being utilized.

The after-school tutoring, which is just the tutoring done by North Boone staff, not through the NIU Imitative, was presented first. Following is the number of students that are invited to after school tutoring:

Poplar Grove Elementary – Literacy – 19 students
Poplar Grove Elementary – Math – 12 students
Manchester Elementary – Literacy – 7 students
Capron Elementary – Math – 47 students
NB Upper Elementary – Literacy – 10 students
NB Middle School – Writing – 21 students
NB Middle School – Test Taking Strategies: Reading & Writing – 9 students
NB Middle School - Math – 20 students

The learning loss part of ESSER is how the teachers are paid. Each teacher provides a proposal to their principal which does get forwarded to both Mrs. Neri and Dr. Greenlee for approval. The tutoring takes place 2-3 times per week for an hour after school.

The total usage of online tutoring, through Paper, from August 22 – December 5, 2022 is as follows:

This tutoring is available online, 24 hours a day. The requested tutoring topics breakdown is as follows:

NB Middle School: Essay Writing – 73%

Reading Comprehension – 8%

Basic Arithmetic – 7%

Equations -2%Other -5%

NB High School: Basic Arithmetic – 20%

Spanish as a Second Language – 19%

Spanish Essay Writing – 13%

Equations – 7% Basic Geometry – 6%

Reading Comprehension – 6%

Other-10%

Some discussion was had on having more teachers using this tool as part of their classes. The Middle School teachers are using it and the hope is to get the younger students used to using it so that they continue when moving on to the High School. The students do seem to be embracing this tool. The expectations, from the admin team, was that they had really hoped it would catch on and have been really pushing it out through presentations and conversations and are very please with the outcome.
