Dr. Greenlee stated Mary Haverly, parent of an Immanuel Lutheran student requested the Policy Committee review policy 7:40, as Ms. Haverly would like her son to participate in the NBMS football program.

Dr. Greenlee read the following language from the August 2015 PRESS version of policy 7:40 which states in footnote #6: “State law is silent on this issue; however, the Illinois High School Association Bylaws, 3.011 and 4.011, state that in order to be eligible to participate in interscholastic competition a student must be enrolled in a district school and take a minimum of 25 credit hours of work for which the district will grant high school credit upon the student’s passing the course. If the board decides not to allow such participation, consider omitting this section of the policy and substituting: Nonpublic school students, regardless of whether they attend a District school part-time, will not be allowed to participate in any extracurricular activities.”

Dr. Greenlee also gathered information from the IHSA, IESA and the Mid-Northern conference. After reviewing and discussing these bylaws, the Committee agreed not to change the current language of this policy, which does not allow extra-curricular participation for students that do not attend North Boone schools.

Dr. Greenlee shared that Exhibit 2:125-E3 – Resolution to Regulate Expense Reimbursements will be presented for adoption at the next Regular Board meeting. The Committee agreed to a \$4,000.00 maximum reimbursement rate, and recommended presenting this resolution at the July 25, 2017 Board meeting.
